Cleopatra Hospital Group partners with Mumtada Medical Company to launch a groundbreaking healthcare facility in Riyadh, Saudi Arabia.

- There is an urgent gap for rehabilitation and long-term care in Saudi Arabia, with an estimated need of 18,000 beds (2030) and USD 14bn market.
- Cleopatra Hospitals Group (CHG) has been selected as the operating partner.
- Mumtada Medical Company, aligned with Saudi Arabia's Vision 2030 healthcare transformation, will provide accessible, high-quality healthcare, and enhance the local workforce and training.
- Riyadh facility to open in 2024, with 200 beds, 27 specialized clinics and 17 dialysis units. Additional facilities across KSA are under consideration.

Through this partnership, CHG will enter the attractive Saudi Arabian healthcare market through an asset light model, expanding the Company's geographic footprint and patient pool further, and building a platform for future growth opportunities.

Cleopatra Hospitals Group (CHG), the leading provider of healthcare services in Egypt, has entered into a partnership with Mumtada Medical Company (herein referred to as "Mumtada") to support the launch of a new 200-bed rehabilitation and long-term post-acute care facility in Riyadh, Saudi Arabia. This partnership signifies CHG's first venture into the Saudi healthcare market, utilizing an asset-light strategy with Mumtada, where CHG will support Mumtada's operations in the Kingdom. Expected to commence operations in late 2024, Mumtada Rehabilitation Facility in Riyadh will provide long-term care, post-acute rehabilitation, and outpatient services, addressing a diverse array of medical needs.

Cleopatra will contribute its operational expertise, shared services, staffing solutions, and advisory support to establish the facility as a top-tier destination for rehabilitation and long-term care. This initiative is the first among multiple rehabilitation and long-term care facilities planned by Mumtada. Cleopatra is led by a seasoned industry management team under the guidance of an experienced board of directors including representation from the Public Investment Fund of Saudi Arabia.

In accordance with the agreement, CHG will be compensated with pre-operational and operational services fees, in addition to performance-based incentives following the facility's opening.

CHG looks forward to working closely with its partners to launch Mumtada Rehabilitation Facility and make a positive impact on the lives of patients and families in Riyadh.

About Mumtada Medical Company

Mumtada Medical Company, headquartered in Riyadh, KSA, aims to transform the healthcare model for specialized rehabilitation and Long-Term Post-Acute Care in KSA. The model will shift away from a sterile hospital setting to a patient and family centric healthcare experience with an integrated continuum of care across inpatient, outpatient, home services and virtual care.

Mumtada Rehabilitation Facility in Riyadh will be the first by the group, planned to open by end of 2024. The facility will include 200 inpatient beds, 27 outpatient clinics, 17 hemodialysis stations, diagnostic laboratory, pharmacy, radiology and multiple support units to serve the needs of patients across a wide range of medical conditions for Adults, Pediatrics, Long-term ventilated care with 24 hours ICU and HDU support.

Mumtada Medical Company is at advanced stages of identifying additional facilities across KSA to rapidly expand the footprint to provide broader access and the highest quality of care to patients in all parts of the nation.
